# MBJ - Copyright Assignment Agreement for a Contribution to a Periodical, Non-Exclusive

Hereinafter referred to as the "Journal," on the other part.
Preamble
The Journal publishes a periodical entitled Multidisciplinary Biomechanics Journal (hereinafter the
"Periodical"), for which the dissemination is entrusted to Episciences.
The Author has submitted an article provisionally entitled
(hereinafter the "Contribution") to the Journal for publication in volume 3   2026 of the Periodical.

#### **Definitions**

Between the undersigned:

- **Episciences**: A comprehensive publishing platform offering open access scientific journals composed of articles submitted via deposit in an open archive.
- **Open access**: The mode of dissemination of texts that makes them accessible on the Web without any payment or identification condition.
- **Final version of the manuscript accepted for publication**: The version whose content has been scientifically validated and editorially formatted (standardized, harmonized, and structured).
- Publisher's PDF: Final version of the manuscript accepted for publication after typesetting.

#### **Article 1 - Object of the Agreement**

The Author hereby assigns, on a non-exclusive basis, to the Journal all rights of exploitation of their Contribution in printed and digital form.

#### **Article 2 - Author's Obligations**

The Author agrees to submit the final and complete Contribution to the Journal no later than 03/05/2026, carefully proofread and finalized according to the editorial Recommendations provided to the Author or accessible online on the Periodical's website.

The Contribution must be supplied as text files (in .doc or .docx format) accompanied by any image files (in .jpeg or .png format at 300 dpi).

The Author guarantees that the Contribution is original and has never been published by another publisher.

If the Contribution contains excerpts or illustrations taken from other works, the Author commits to provide the Journal all necessary reproduction authorizations for publication.

The Author further guarantees that the Contribution contains nothing illegal or liable to engage the responsibility of the Journal, and guarantees the Journal the full enjoyment of the assigned rights against any disturbance, claim, or eviction.

The Journal shall take charge of posting the accepted manuscript and publisher's PDF on the open HAL archive, a necessary step for online posting on Episciences.

## Article 3 - Assignment of Rights for Printed and Digital Exploitation

The Author assigns to the Journal the rights to reproduce, represent, and adapt the Contribution in printed form and notably:

- The right to reproduce the Contribution within the Periodical or separately in all analog and current or future electronic, opto-digital, or magnetic supports such as CDs and USB keys, by press, including pre- and post-publication, micro-reproduction, and photocopy;
- The right to translate all or part of the Contribution into any language and reproduce the translations on all aforementioned supports;
- The right to represent the Contribution and its translations in the Periodical or separately by any current or future means of public communication, including public reading, dramatic representation, lyrical execution, any telecommunication means including radio, television, media on demand via terrestrial, cable or satellite, as well as Internet broadcast excluding any audiovisual adaptation.

The Author also assigns to the Journal the right to exploit the Contribution digitally, including:

- Reproduction in electronic formats such as HTML, XML, PDF, ePub on all current or future digital storage supports including Internet servers, USB keys, hard drives, memory cards, tablets, computers, e-readers, mobile phones, e-paper;
- Public communication online or by subscription or per use via all means, including networks
  of all legal public or private entities such as companies, libraries, educational and research
  institutions;
- Adaptation into multimedia formats or integration into multimedia works, reproduction and representation by all previously mentioned means.

The Author authorizes the Journal to distribute the Contribution in open access under the Creative Commons CC-BY 4.0 license for all modes and supports of exploitation mentioned above.

Given the knowledge dissemination mission and the research results publication framework (Code of Education, article L. 123-6), and pursuant to article L. 122-7 of the Intellectual Property Code, the Author expressly grants these rights gratuitously to the Journal.

This gratuitous assignment is non-exclusive, worldwide, in all languages, for the duration of copyright protection under French and foreign laws as well as current and future international conventions, including any extensions.

The Journal may exercise these rights itself or assign them to third parties, informing the Author if so. As the assignment is non-exclusive, the Author may publish the Contribution with another publisher later, provided the full bibliographical reference of the first publication in volume 3 | 2026 of Multidisciplinary Biomechanics Journal is mentioned.

## Article 4 - Journal's Obligations

The Journal commits to publish the Contribution in volume 3 | 2026 of the Periodical within 6 months of receiving it from the Author.

Before publication, the Journal ensures the Contribution meets academic publishing standards and adds editorial value (orthotypographic checks, bibliography control and formatting, structuring, image processing).

The Journal commits to submitting to the Author a proof of the formatted Contribution for digital approval.

If the Contribution is to be exploited in both printed and digital versions, the Author's approval of the proof is valid for both, provided they do not differ except for minor digital-specific additions such as hyperlinks.

## **Article 5 - Open Archive Deposit Policy**

The Journal will deposit the publisher's PDF in the open HAL archive and apply the CC-BY 4.0 license, according to its open access dissemination policy.

Academic social networks like ResearchGate or Academia.edu are not open archives; deposits must be made in an open archive for longevity, with possible links from academic social networks.

## Article 6 - Applicable Law and Dispute Resolution

This agreement is subject to French law. Any dispute arising from this agreement shall first be submitted to mediation before any court proceedings.
